

# Steering Committee Meeting 5-1-19 NOTES

### **Updates:**

June 7 HCA All-Partner Meeting – John discussed possible pairing of a grant writing primer or workshop of some kind. Presenters to include Muncie Public Library, Fred Hoffman, and a possible speaker from Jay County. Group discussed a presentation about the HCA partnership that is making laundry coupons available to resource limited audiences. John will follow up on that. Will invite White Spot Laundry to take part- for laundry coupon project as well as recognizing during the tobacco portion of the program. (No steering committee meeting June 5).

Purdue Extension- Chelsie Jaramillo reported that:

-Blackford HCA Workgroup has advanced projects forward related to community garden and greenway signage; however some items have stalled due to funding , materials and weather. The group will next meet May 24 to re-assess initiatives.

-Food Council is working on farm to school facilitation and food rescue communication initiatives.

-Annual farmers market list will be ready by July. John will share with HCA Partners. -Urban Garden Coalition will be present at Minnetrista Garden Fair this year, also providing guidance for the Ivy tech/MITS/Sunrise Rotary discussions regarding moving raised beds to Seymour Street location.

Molly noted that she hopes the new Community Wellness Coordinator to be in place by June 3 (replacing Chelsie who has accepted a position in Madison County. Purdue Extension has a Horticulture Educator (Lauren) working on creating a partnership involving Master Gardeners. Purdue Extension, Muncie Food Hub and other partners with big ideas about community gardening, distribution etc., applying for a competitive grant to fund the ideas. Molly will also be taking training to offer adolescent substance abuse sessions for parents in June or July. John will share info with partners when available.

Del Co. Wellness Professionals – Nathan is spearheading Delaware County's renewal of the Indiana Healthy Community designation, engaged the DC Wellness group in April to fill out the application, he is now following up on questions and additional details. Next meeting is May 8, and will feature guest presenter Nicole Fallowfield, wellness council board member and workplace wellness paradigm pioneer will present on incentives, employee engagement and motivation.



### **HCA Jay County Meeting and Recruitment:**

John will be making a presentation to the Jay County Systems of Care Meeting May 14, this is a group that meets monthly to discuss safety net type resources in the community.

John will also present to the Portland Rotary Club June 5. His goal is to grow Jay County Partners by at least 5 in 2019.

Localized toolkit updates from Feb. Jay Workgroup- the Healthy Weight and Active Lifestyle Toolkit has been updated with Jay County resource information and will be unveiled at the upcoming May 10 Jay County Workgroup Meeting.

John reported on behalf of Jordan, who was unable to attend. No Menthol Sunday - May 19th, we have a little over 20 churches participating so far.
